# Development of the 2022-2024 Conservation and Load Management Plan & COVID-19 Program Impacts and Planning

The Connecticut Energy Efficiency Board (EEB) invites you to a Public Input Session for development of the 2022-2024 Conservation and Load Management (C&LM) Plan. The session will be held on Wednesday, March 10, 2021, 12:30 pm – 1:15 pm, with additional public comment meetings to be scheduled later during 2021 calendar year. The meeting is webinar only; webinar information is provided below. Please note: the EEB will hold its March monthly meeting, also by webinar, immediately following the Public Input Sessions.

Established through CGS 16-245m, the EEB is comprised of ten voting members representing business and consumer interests as well as state agencies, and five non-voting representatives of the state's electric and gas utilities. It advises and assists the utilities in the development and implementation of Connecticut's energy efficiency and demand response plans.

The EEB welcomes input as part of its collaborative process with the electric and gas utility companies, the Department of Energy and Environmental Protection (DEEP), the CT Green Bank, interested stakeholders and the general public, for developing the 2022-2024 C&LM Plan. Input will inform DEEP about the allocation of C&LM resources for energy efficiency and demand response programs and related activities for the 2022 calendar year. During this meeting, the EEB would also like to take comments on COVID-19-related impacts on current operations, program, and planning.
